## January 2022

## Gender

18-Rome: The UfM signs the Memorandum of Understanding "No Women No Panel," an initiative by the European Commission and RAI. The Union for the Mediterranean participates in the campaign seeking to improve gender representation and equality in public debates in the Euro-Mediterranean Region. This Memorandum of Understanding commits the UfM and other signatory bodies to include female and male participants on panels as equally as possible.

## Migrations

19-Brussels: The new European Union Agency for Asylum starts work with its reinforced mandate, building on the achievements of its predecessor, the European Asylum Support Office. The new agency is a key deliverable under the New Pact on Migration and Asylum. It will help ensure that asylum decisions are taken in a fast and fair manner and that reception standards converge across the EU, increasing uniformity in decisionmaking and alignment between Member States' asylum systems. The new agency will receive €172 million of EU funds in 2022 and will launch eight operations supporting asylum and reception authorities in Member States.

These donations, which were facilitated by COVAX, are part of ongoing efforts by the European Union and its Member States to provide

Syrians across the country with adequate protection against the Covid-19 pandemic. The EU and its Member States are so far the biggest donor of Covid-19 vaccines in the world, having donated over 350 million doses to countries around the world.

#### Grain Sector

24-London: The EBRD signs a sovereign guaranteed loan for €150.5 million to the Office des Cereales (ODC), a Tunisian state-owned company, to fund imports of soft wheat, durum wheat and barley, representing up to 15 percent of Tunisia's annual consumption needs. The war on Ukraine has severely impacted the country's ability to export grains and has led to disruptions in the global grain supply and hikes in global soft commodity prices, which directly impact the southern and eastern Mediterranean countries - some of which are the world's largest importers of wheat. BRD, ODC and Tunisian authorities expect to develop a roadmap to improve grain sector efficiency and address some structural weaknesses.

The Forum also hosts a Euro-Mediterranean youth meeting organized by the UfM Secretariat and the Anna Lindh Foundation.

The AAWDCP will supply an additional 300 million cubic metres of water each year after desalination and transfer it from Aqaba to the Jordanian capital and all other provinces.
